Fish Tacos

Weeknight win: fast, fresh, and affordable.

INGREDIENTS:

- 1 lb white fish (tilapia, cod, etc.)
- Salt & pepper

Marinade:

- 2 Tbsp oil, juice of 1 lime, 1 clove garlic (minced)
- 1½ tsp chili powder, 1 tsp cumin, ½ tsp paprika, cayenne to taste

Sauce:

- ½ cup sour cream, ⅓ cup mayo
- Juice of 1 lime, ½ tsp garlic powder, ½ tsp cumin, ¼ tsp salt, Sriracha to taste.

Pico de Gallo:

- 5-6 diced roma tomatoes, 1 red onion, 1 jalapeño, cilantro, lime juice, salt & pepper

To Serve:

- 8 white corn tortillas
- Shredded cabbage

DIRECTIONS:

Marinate fish 20–30 min. Grill 3–4 min per side, flipping once. Warm tortillas on the grill. Break fish into chunks. Assemble tacos with cabbage, pico, and sauce. Top with extra lime or hot sauce if desired.

The Golden Rules Of Financial Freedom

In personal finance, not all goals are created equal. Before you can focus on building wealth or leaving a legacy, you first need to meet your basic financial needs.

That's why I created The Personal Finance Hierarchy of Needs — a simple framework to help you visualize the stages of financial growth, from survival to significance.

Here's a quick breakdown:

1- Cash Flow & Basic Needs: At the foundation, it's all about control. You must earn more than you spend on essentials like food, housing, transportation, and clothing. Positive cash flow is where financial security begins.

2- Safety: Once your basic needs are met, it's time to protect yourself. This means building an emergency fund (3–6 months of expenses) and making sure you're properly insured — health, life, and disability. It also means starting to save at least 1% of your income for retirement.

3- Accumulation & Wealth Building: With stability comes opportunity. At this stage, you eliminate bad debt like credit card balances and start aggressively investing 10% to 50% of your income. You might even begin exploring passive income streams or entrepreneurship.

4- Financial Freedom: Imagine a life where you no longer have to work because your investments and passive income cover your expenses. That's the goal here — working becomes a choice, not a necessity.

5- Legacy & Self-Actualization: The peak of the hierarchy is about meaning. You have more resources than you could ever spend in a lifetime. Now, it's about leaving an inheritance and using your wealth to live out your life's true purpose.

Most financial advice skips straight to talking about retirement accounts or investing, but without a strong foundation, those strategies fall apart.

This hierarchy ensures you're building your financial life in the right order — from survival to significance.
